RATE RECOMMENDATIONS

Apply 12.8 oz per acre with a minimum 10 gallons of water. Highly compatible tank mix partner with most herbicide and fertility programs.

Optimum rate of application will vary depending on treatment interval, soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and its nutrient requirements. For best results, follow soil/tissue test recommendation.

MIXING AND HANDLING INSTRUCTIONS Fill mix tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, then fertilizers. Fill tank with remainder of water and continue agitation until solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application, especially for high phosphate and alkaline (high pH) solutions.
